### About Creative Kids

Creative Kids funds families with financial barriers so more children can explore their creative and cultural passions.

- Saskatchewan children ages 4 to 19 are eligible
- Families must demonstrate financial barriers
- Funding is for activities that are primarily artistic and/or cultural

Creative Kids may provide up to \$750 for a child's activity. If an application is funded, Creative Kids pays the service provider (business or instructor) directly. Funding resets each June 1.

### Application deadlines

Application deadlines and eligible activities are listed at [www.CreativeKidsSask.ca](http://www.CreativeKidsSask.ca).

Mailed applications must be received by the deadline date.

Application results will be emailed to you within 30 days of an application deadline.

### Demonstrating Current Financial Barriers

Include your most recent Notice of Assessment from Canada Revenue Agency. If there is a significant difference in your financial situation, also include 2 current pay stubs or other documents verifying your current household income.

Before your activity begins, send your application to the address/email on the last page of this application form.

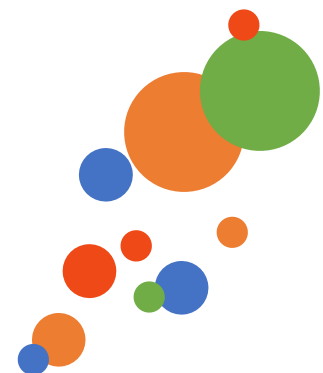
